

# Privacy Policy

The present data protection information concerns the users of the website **SDR.hu** and the services available thereat, as data subjects. The purpose of the data protection information is that András Retzler (hereinafter referred to as "Owner", available at the e-mail address: <[randras@sdr.hu](mailto:randras@sdr.hu)>), who is an individual with the address 2 Littke József street, 7632 Pécs, Hungary, may inform the data subjects regarding the processing of the data received.

SDR.hu is a personal website of an individual, the Owner. SDR.hu is neither a professional, nor a business website. It serves the amateur radio hobby.

As the data subject may decide freely whether to use the service, the data and information required for the use of such service are freely given.

To access certain parts of the services of SDR.hu, registration is required. During registration, SDR.hu requests the following data to be provided, and processes such data:

- Data required for the seamless operation of the services offered by the SDR.hu website: first name, last name, amateur radio call sign, IP address.
- Unique identifiers required for the use of the services offered by SDR.hu: e-mail address, password.

We use this data:

- to check if you are eligible to use the service,
- to contact you about matters strictly related to the service,
- to defend against abuse of the service,
- to grant you access to certain parts of the SDR.hu website, including, but not limited to: viewing, changing and deleting your personal information.

While using SDR.hu and OpenWebRX together with your unique API key you received from SDR.hu, the server at SDR.hu automatically crawls the web interface of your radio receivers in which you configured your unique API key (using the "/status" URL) and collects the following information from your receiver:

- title of the receiver,
- IP address of the receiver,
- URL of the receiver,
- frequency bands of the receiver,
- number of users on your receiver,
- maximum allowed number of users on your receiver,
- the avatar image set on your receiver along with its last modification date and time,
- the GPS coordinates of your receiver,
- ASL height of your receiver,

As you have visited our website, you must register in order to be able to some of the services offered thereat (including, but not limited to listing your own amateur radio receivers). For the purposes of the registration, we need some personal data from you.

Your data remains to be yours. The data remains at your disposal at all times. You may decide what may and may not happen to your data.

SDR.hu is a personal website, still it respects your privacy.

We use only the data provided by you and listed hereat. During the use of the system, further data are generated, but these may not be linked with you afterwards. We need these so that our system may be used more conveniently.

- software and hardware type and version of your receiver,
- the antenna you connected to your receiver,
- an additional contact e-mail address to you, the administrator of the receiver.

We use this data:

- to list all of these details at SDR.hu (even though listing some of these might not be yet implemented),
- to contact you about problems with your receiver.

You can delete all of the personal data SDR.hu collects from you using the "Login / My Account" feature. Note that this deletes your personal data from our database immediately, however, your personal data might still be retained in our backups and will finally be erased from those within 12 months from the account deletion.

When you choose to visit our website, data such as the IP address (the internet protocol address of your computer), the date, the visited sites and other technical data are logged as well. All this happens on an anonymous basis, therefore such data may not be linked with you, neither now nor in the future. We do not analyse data, they serve exclusively statistical purposes. After the statistical analysis – which we use to ascertain how many visitors we have and how we may ensure the appropriately prompt functioning of our sites – we erase the data.

We use Matomo/Piwik software for web analytics, with tracking cookies disabled. If you want to opt out of all web analytics we use, you can do so here (this will set a "piwik\_ignore" cookie on your web browser):

### **Method and duration of data management**

Data management is carried out by the Owner on servers he leases. In addition, data may be temporarily stored on the Owner's other computers as well.

The duration of the data management lasts from the user registration until the deletion of the registration.

The duration of the processing of visitor data lasts until the log files are processed, the latter being stored for up to a year.

### **Data protection**

In order to avoid the unauthorized use of the processed personal data and related misuse, the Owner applies extensive technical and operational security measures. These security processes are regularly reviewed and

We store personal data in an IT system, and only until necessary, that is for the duration of the registration. Personal data are not printed or disclosed to anybody, neither orally nor through other means.

If you do not wish to continue to use our services, you may delete your registration at any time, and thus also your data shared with us.

To ensure the protection of data, we maintain a system and control mechanism of appropriate security standards.

### **Access to own data**

The data subject may access at any time and without limitation his/her personal data through the 'Login / My Account' function of the website, where all data may be accessed, modified and erased. Should this function not be available for any reason, please contact the Owner in writing at [randras@sdr.hu](mailto:randras@sdr.hu).

You have the right to enquire at any time regarding your data we store. You may do this most conveniently in the system at the data sheet pertaining to your registration, but may also request, through any other means, that we informed you about your data we store.

### **Data transfer, further recipients**

In order to provide seamless operation of the services offered by the SDR.hu website, we use Virtual Private Servers hosted by Digital Ocean, LLC, which means that your personal data is transferred to their systems. The Data Processing Agreement (available at: <https://www.digitalocean.com/security/gdpr/data-processing-agreement/>) between the Owner and Digital Ocean, LLC controls this data transfer. The VPS that hosts SDR.hu resides inside the European Union.

We only transfer your data to our hosting provider, Digital Ocean. They may transfer it to the USA for their operations.

In certain cases Digital Ocean, LLC might forward data to the United States of America in order to provide seamless operation of the services. Digital Ocean, LLC provides a level of protection of privacy that complies with the EU rules, and to confirm this, they have certified their company under the Privacy Shield (notice available at: <https://www.digitalocean.com/security/privacy-shield/>)

### **Automated decision-making**

Our system does not automatically create a profile based on the visitor data of the data subject.

We do not create a profile of our visitors and make the system behave differently based on the profile.

### **Updates to this Privacy Policy**

The Owner reserves the right to update this Privacy Policy from time to time in order to reflect changes in the law and the data collection and use practices of this website. By continuing to use SDR.hu, you accept those changes.

Please check back regularly because this privacy policy might change. We will notify you when we are obliged by law to do so.

### **Enforcement of rights**

You may lodge a complaint at us with respect to data management or any element thereof, at the Owner via a complaint addressed to [<randras@sdr.hu>](mailto:randras@sdr.hu).
